

# New Consultancy and Relief Organization Fact Sheet

## 1. Introduction:

Owing to the constant human suffering caused by the civil war in Afghanistan, we decided to create a nongovernmental organization, Narcotic Control and Rehabilitation of Afghanistan in 1993. Being renamed in 2005, National Consultancy and Relief Association, and later on the appellation changed in 2012 to New Consultancy and Relief Organization (NCRO). NCRO was established with a view to serving the needy Afghans, particularly Afghan Returnees from neighboring countries and the internally displaced persons (IDPs) due to natural disasters or internal conflicts in Afghanistan. NCRO is a fully voluntary organization and provides services to the aforementioned categories of people, irrespective of gender, race, language or geographical locations. NCRO assistance is always free and within the rules and regulations of the country. It never seeks compensation or reimbursement from its beneficiaries.

NCRO is registered as a nongovernmental organization, with the government (Ministry of Economy).

#### 2. Governance:

Since NCRO is governed by a board of directors including five members with diverse expertise and educational backgrounds, the decisions are made by the mentioned board of directors, in case of a challenge or a potential problem in decision making; issues are decided by a vote of the majority.

# 10. Current Partnership:

#### 10.1 - UNOCHA/AHF - Afghanistan:

Afghanistan Humanitarian Fund (AHF): NCRO is a Partner of the AHF Afghanistan.

NCRO passed the AHF Due Diligence Initial Review process and obtained an "A Category" of CHF partners in step one. Later in 2016, NCRO participated in a Capacity Assessment process with OCHA's independent contractor **KPMG** (step two). KPMG carried out a capacity assessment of the NCRO in accordance with the capacity assessment tool developed by UNOCHA for AHF partner assessments. The assessment included the review of key documents, interviews with NCRO key staff and tests of compliance with the organisation have stated procedures to the extent that such testing was deemed necessary and feasible. Based on the capacity assessment conducted by KPMG firm, which took account of management responsibilities described above, in accordance with OCHA's assessment tool, NCRO was assessed as a **Medium risk** partner.

#### 10.2 - UNHCR:

NCRO has been a successful partner of UNHCR (Partner MSRP Code 1001148) and has been implementing UNHCR projects since 1996 in the Eastern Region of Afghanistan.

In late 2015, UNHCR issued a confirmation letter NCRO Pre-qualification Procurement signed by Mr. Stephen Ingles, Head of Procurement Service, UNHCR GSC, Budapest.

The granted status with national scope is valid from 30 January 2016 to 31 December 2020.

#### 10.3 - WFP:

NCRO has been an active partner of WFP-Afghanistan since 1996. NCRO has passed the recent Capacity assessment of WFP in 2012. NCRO is implementing WFP Food for work, Food for asset (food distribution and cash transfer) and food for training projects in the eastern region of Afghanistan.

### 10.4- FAO:

NCRO has been a partner of FAO-Afghanistan since 1993. NCRO has implemented seed distribution, Fruit and forest Nursery, Sugar can, vegetable seed, Livestock and Irrigation projects in the eastern region of Afghanistan. NCRO currently has agriculture, livestock, and CFW, UCT and water infrastructure project in Kunar, Nuristan and Laghman province.

#### 10.5- WHH:

NCRO has been a partner of Deutsche Welthungerhilfe e.V (WHH) Afghanistan and has completed two feasibility studies; one in Renewable Energy in Nangrahr province and the second a of Irrigation project in Kabul province in 2015. NCRO is a national twinning partner of WHH since the beginning of 2016.

NCRO passed the WHH partners capacity assessment and obtained WHH partnership in 2016, WHH carried out a capacity assessment of the NCRO in accordance with the capacity assessment tool developed by WHH for Partner assessments. The assessment included the review of key documents, interviews with NCRO key staff and tests of compliance with the organisation have stated procedures to the extent that such testing was deemed necessary and feasible.

Based on the capacity assessment conducted by WHH NCRO was assessed as WHH partner and currently NCRO is implementing AA/WHH funded permanent shelter (Each having, two rooms, one corridor, one kitchen and one Latrine) project for 265 needy families including IDP, returnee in Nangarhar province.

NCRO is implementing BMZ/WHH funded Food Security and Nutrition project for returnee in Laghman province.

#### 10.6- OXFAM:

NCRO has been a partner of Oxfam Afghanistan and has completed two Humanitarian response projects in 2018 and 2019 in Nangarhar province.

NCRO passed the OXFAM partners capacity assessment and obtained OXFAM partnership in 2018, Oxfam carried out a capacity assessment of the NCRO in accordance with the capacity assessment tool developed by Oxfam for partner assessments. The assessment included the review of key documents, interviews with NCRO key staff and tests of compliance with the organisation have stated procedures to the extent that such testing was deemed necessary and feasible.

Based on the capacity assessment conducted by Oxfam NCRO was assessed as Oxfam partner to implement two humanitarian response projects in 2018 and 2019 which includes Water, Sanitation, Food security, Shelter, for conflict affected people, returnee and IDPs in Nangarhar province.

#### 11.NCRO Vision:

To see all Afghan communities socially and economically self-reliant.

#### 12.NCRO Mission:

The New Consultancy and Relief Organization is a nongovernmental humanitarian organization which assists in the alleviation of human suffering. The mission inter alia includes:

- Safe and smooth return of internally displaced people and Returnees to their local communities or country of origin.
- Provide humanitarian assistance to the needy Returnees and IDPs, leading to their smooth reintegration in respect to
  the conditions prevailing in their relevant local communities.
- Raise awareness in health related issues, rehabilitate or reconstruct basic infrastructures for irrigation and water supply schemes, build tertiary roads for economic stimulation, design and implement income generating projects.
- Quick response to the emergencies arising from both natural and man-made disasters in the eastern provinces of Afghanistan.

# 13. Objectives:

- a. To serve the needy and marginalized families by undertaking relief and rehabilitation response during and after emergency situations.
- b. To participate actively in the national development and rehabilitation programs.
- c. To promote licit crops for making Afghanistan a poppy free country, provide high quality improved grain seeds, and establish fruit and forest tree nurseries.
- d. To establish vocational training centers and implement income generation projects for families' well being and self-sufficiency.
- e. To rehabilitate basic infrastructures, particularly irrigation systems, essential for the affected communities' socioeconomic survival.
- f. To provide timely humanitarian assistance to all needy communities in the country.
- g. To protect Returnees and IDPs with legal procedures in collaboration with national and local government authorities.

#### 14. Who We Serve:

NCRO supports the Returnees and IDPs, natural disaster and conflict affected people as well as people living in poverty who are in need of humanitarian assistance and livelihood, within the host communities.

# 15. Programs and Services:

NCRO provides basic humanitarian services:

- In health, NCRO organizes families' hygiene awareness campaigns.
- In water supply, NCRO executes pipe schemes, dig potable water wells, deep wells equipped with solar powered water pumps and hygiene education as a component of the drinking water supply projects.
- In sanitation, NCRO constructs latrines and improved waste water drainage systems and makes garbage bins.
- In Agriculture, NCRO distributes improved crop and vegetable seeds, establishes tree nurseries, and trains women in setting up kitchen gardens.
- In livestock, NCRO promotes making fish ponds along river banks, distributes cows, goats, poultries and kitchen garden to families in need.
- In irrigation, NCRO constructs water intakes and siphons, rehabilitates canals, cleans karezes and builds protection walls.
- In infrastructure, NCRO constructs school and clinic buildings, and rehabilitates tertiary roads and walk paths.
- NCRO designs and implements shelter construction projects for Returnees and IDPs.
- In capacity building, NCRO provides income generation trainings for young people.
- In consultancy, NCRO carries out Returnees and IDPs need assessment, implements projects, remote monitoring, awareness rising and women right advocacy and conducts project feasibility studies.
- In renewable energy, NCRO installs photovoltaic panels and constructs micro hydropower systems generating energy for domestic consumption, installs ram pumps for irrigating agricultural lands.

#### 16.Goals:

- 1. Enhanced individual and family economic sustainability.
- 2. Ensured food security of vulnerable communities.

- 4. Launched adequate humanitarian emergency response in crises.

#### 16.1. Goal 1: Enhanced individual and family economic sustainability

In addition to the Returnees and IDP communities, about half of the people live under the poverty line in Afghanistan. They are in need of food, water, shelter, power, and other basic needs for a decent life. NCRO seeks resources and actively supports the needy to initiate economic activities in order to play a vital role in meeting the humanitarian challenges by providing them with skills, resources and required tools, as well as lead the discussions with stake holders about how to conceptualize sustainable economic models. NCRO carries out need assessments and market assessments to have access to updated information on current conditions, empowerment of women with feasible support, and assistance to other marginalized and vulnerable individuals and families.

#### **Strategies:**

- a. Conduct beneficiary selection and assessment for shelter assistance, train beneficiaries in shelter constructions matching shelter guide lines and hygiene standards, distribute construction materials for shelter and provide cash support for skilled labors wages.
- b. Provide potable water to the needy by digging shallow wells, installing pipe schemes; make tube wells equipped with solar panels and electric water pumps.
- Provide education facilities by Construction of school and support needy students to enable them to continue their education.
- d. Enhance public dialogue and discussion with stakeholders on people's economic sustainability by producing practical analyses of economic realities and the applicable management strategies.
- e. Provide strategic guidance to beneficiaries in order to enhance their purchase power and affordability for maintaining sustainable healthy and decent living conditions.
- f. Identify resources, implements, and community needs to form feasible income generating systems to empower women and vulnerable community members.

### 16.2. Goal 2: Strengthened food security

Population growth, demographic changes, increasing affluence and urbanization, climate and other environmental changes with social, economic and political ambitions has a great impact on food security. Affordability and availability of food is closely linked with the need to reduce poverty. Key resources for agriculture notably land, fresh water and energy are limited. Urbanization, demographic change, issues of land tenure, governance and security, changing patterns of consumer needs, preferences, choices, tastes, habits and practices, affect the demand for and

consumption of different foods and patterns of waste. Government policy changes and political instability are political factors leading to food insecurity.

Afghanistan is an agricultural country with limited irrigated land compared to its population and unused water resources. Protracted war situation, civil strife, and natural disasters particularly drought affect crop production and therefore increases people vulnerability against food security. People have no adequate economic resources for making cash which would enable them to purchase food stuff. A large number of people have lived on food donations from the UN and other international organizations in the past. It is suspected that without timely and thoughtful intervention, the people will definitely face food shortages, with severe consequences. NCRO, therefore, devises a comprehensive strategy to cope with the situation reducing the dependency and alleviating the poverty of the particularly vulnerable communities of Returnees and IDPs. This strategy is making measurable and sustainable improvements in farm production and resource utilization through instruction and skills improvement in growing, processing and marketing practices.

Over the past twenty four years, NCRO has successfully improved food security for populations at risk through technical interventions in areas such as post-harvest management, processing and storage, animal husbandry, agricultural marketing, bullock traction, agro-forestry, inventory credit, and the formation of farming groups and committees.

Our specific areas of expertise in programming include:

- Working with women farmers
- Workforce & Enterprise Development
- Food Security & Agriculture
- Health & Nutrition
- Irrigation water
- Finance Development
- Post-Conflict Rehabilitation

#### **Strategies:**

- a. Provide direct technical assistance to farmers through field extension agents who live and work in communities to promote changes in attitudes and systems with the aim at enhancing clients' skills in agriculture. NCRO does not simply equip farmers with new tools, it also empowers rural farmers with skills and knowledge needed to generate increased production and profit promoting respect for the environment and improving the quality of life for the community as a whole.
- b. Improve farming systems, invigorate entrepreneurship, and strengthen market systems for increasing food availability and access to food supplies.
- c. Improve food utilization through food distribution and better care practices such as improved food processing, preservation and storage.

## 16.3. Goal 3: Protected and reintegrate Returnees and IDPs in native communities

People living for a long time away from their native communities often change their social behavior and character and grasp new attitude and habits different than their original. Their ways of income and means of livelihood earning are often different from the local population. This makes them alien to their former native communities and their reintegration therefore becomes problematic after they return. Some of the Returnees fear for their safety, dignity and rights. NCRO intends to address these most fundamental rights involved in humanitarian response. Our humanitarian protection concerns are freedom from violence and deliberate deprivation of the means of survival and dignity. We enjoy the expertise to make proper arrangement in collaboration with the host communities, local authorities and the resettled communities.

#### **Strategies:**

- a. Provide live saving humanitarian assistance for affected people including:
  - al- shelter assistance, provision of shelter assistance to the needy affected people such as permanent shelter. Transitional shelter, shelter repair and upgrade, provision of emergency shelter (tents and house rent), provision of winterization assistance including fuel for heat, none food item.
  - a2 provision of emergency food assistance: provision of food assistance to the needy people in cash based or in kind monthly standard family package of FSAC standard.
  - a3 provision of WASH assistance: provision of WASH assistance to the needy affected people such as provision of drinking water by construction and rehabilitation wells, deep wells, springs, karezes. Provision of sanitation assistance through construction of HHs' latrines, improvement and management of drain waste water and garbage bins. Provision of hygiene awareness rising training and distribution of hygiene kits.
- b. Identify all vulnerable individuals and families suffering from whatsoever threats risking their survival, safety and rights in the resettlement areas and note all potential indicators applicable for the protection plan.
- c. Contact with the concerned local authorities and responsible individuals within the Returnees, IDPs and host communities for seeking their support and cooperation in case of any misunderstanding and confusing situation.
- d. NCRO is committed to coordinate in the protection cluster structure with the local points for child protection, gender-based violence, housing land and property, rule of law and justice.
- e. Maintain regular watch and observation over vulnerable individuals with the help of the identified elements and figures within the neighboring host communities.
- f. Ensure timely action at potential risk emergence to safety and dignity challenges to guarantee individual and family rights.

#### 16.4. Goal 4: Launched adequate humanitarian emergency response in crises

Afghanistan is a landlocked and mountainous country where most of its mountains are dry with no trees. Decades long war has badly stricken it and is often affected by drought. Its water resources have not sufficiently been exploited for agriculture growth. People live in difficult socio economic conditions. Afghanistan is vulnerable to natural disasters and emergencies, as well as being a victim of manmade crises for decades. People often face crises and suffer from emergencies. Earthquake, drought, flood, landslide, and shortage of food and water force people to quit their native habitation and move to rather safer places in the country. These people are often so vulnerable and unable to survive without timely assistance. NCRO realizes its moral obligation to come up with a proper humanitarian emergency response in such occasions.

#### **Strategies:**

- a. Conduct an early comprehensive assessment of the humanitarian emergency crises with the affected individuals and families, and calculate an estimated amount of the assistance required for the case for a particular intervention.
- **b.** Identify potential resourceful assistance organizations for proper humanitarian response with details of the emergency situation and the methods how to address it.
- **c.** Prepare a detail work plan and methodology for how to manage and apply the humanitarian emergency response in an effective and precise way.
- **d.** Obtain stakeholders practical assistance on the ground and ensure full cooperation of all parties working in the area for similar objectives.
